SUMMARIZE

Using a patient seen in the practicum setting, summarize the H&P into an organized and concise format.

CC	Possible yeast infection
HPI statement using OLDCARTS data	<p>***Mrs. Johnson is a 65-year-old female patient presenting at the clinic complaining of "possible yeast infection" after taking antibiotics that the dentist gave her. Mrs. Johnson developed symptoms 2 days ago when she finished taking the 10-day course of antibiotics. The client states the symptoms are localized to the vagina and complains of constant symptoms that are getting worse. The symptoms are localized to the vaginal area and include vaginal itchiness, irritation, redness, inflammation, and burning. She has not noticed an odor, vaginal discharge, or pain. She states that wearing underwear and tight pants have made it worse and that scratching or rubbing the area gives some relief but that the issue is aggravating, and relief only occurs for the moment. No treatments have been attempted and she describes severity as a 5/10. The client does indicate recent sexual intercourse with her partner. The client is a nonsmoker and does not have any significant past medical or surgical history. The patient's vital signs are WNL. On physical exam, a vaginal examination was performed and revealed vulvar and vaginal erythema, inflammation, and a clumpy, thick white discharge inside the vagina. The patient did not indicate any pain or tenderness felt during the exam. I did perform a vaginal wet mount test to be looked under the microscope to determine if bacteria, yeast cells, trichomoniasis or trichomonads, white blood cells, or clue cells are present.</p> <p>O – 2 days ago L – vaginal D – constant symptoms that are getting worse C – itchy, burning, irritation, redness A – underwear/tight pants R – scratching/rubbing area T – none tried S – 5/10</p>

Based on the H&P key findings, identify an appropriate differential.

*** My differential diagnoses are based on the history and physical key findings and I believe this could be a vulvovaginal yeast infection, bacterial vaginosis, or trichomoniasis.

Vulvovaginal yeast infection

- +itching
- +burning
- +redness
- +irritation
- +pH of 4.0 on wet mount examination
- +candidiasis cells found under microscope
- +clumpy, white, thick vaginal discharge

Bacterial vaginosis

- +itchy
- +redness
- +irritation
- +burning
- no fishy odor
- no thin white or gray vaginal discharge
- no soreness
- no history of STDs
- no pH > 4.5
- no clue cells on microscope

Trichomoniasis

- +itchy
